Local arenas competing in Kraft Hockeyville contest

Rolling Hills, Tilley and Duchess have entered the 2025 Kraft Hockeyville contest but support is still required from the public by March 2nd at 11:59 p.m. (9:59 p.m. Mountain Time) in order to reach the next stage.

The annual program, which is now in its 19th year, will award the top submission with \$250,000 for their arena and an NHL pre-season game for either the competing or an alternative arena.

Through the program \$5.1 million has been provided to 101 communities to address the growing costs associated with maintaining or upgrading aging sports and recreation infrastructure.

Rolling Hills is looking to replace their chiller and condenser which are worth about the total of the grand prize.

"A lot of people probably don't really care about the NHL team because it's such a small facility," said Darcy Hensing, president of the Rolling Hills Ag. Society.

The group hopes to win the funds to replace the equipment to help keep their arena alive.

"It's the smaller communities that they say keep Brooks and all these other bigger facilities going.

"If you don't have the facilities in the smaller communities to attract the

people and keep it going, you're going to lose a lot," Hensing said.

The local arena is not only used by the residents but also rented by teams from Calgary, Fort McMurray, Edmonton and Saskatoon for between eight and 10 tournaments each winter.

And bookings have already started for the 2025-26 season.

"We bring in a lot. On the average you get six teams that are booking between 80 to 100 rooms in Brooks.

"They're all out of town teams. We have no local teams from Brooks which really is disappointing."

Fundraising for the construction of the Rolling Hills arena started in 1972, ground was broken for the volunteer-built arena in 1988 and it opened to skaters in 1992.

In 1988 the hamlet received a building for the ice plant and the plant itself was purchased for \$100,000.

The plant had been a back-up at the Calgary Olympics for the opening and closing ceremonies at McMahon Stadium.

Representatives in Tilley would like to add heat and changing rooms to their arena.

Their story submission states that improving the heating would improve the rink substantially.

One person posted that the Tilley arena has a running joke that it is the coldest rink in Alberta.

The heaters cannot be

turned on unless the outside temperature is at least -15C so that the roof sweating doesn't create droplet lines on the ice.

There are no submissions for the Duchess arena.

As of Monday 361 arenas from across Canada, including about 100 from Alberta, have submitted applications.

Now comes the public input.

By March 2 add something to the Duchess, Tilley and/or Rolling Hills arena pages at the Kraft Hockeyville site. Submissions help the arena become a top four finalist.

One note per person is allowed and it is worth one point, up to 15 reactions to a photo or story submission per person per arena are allowed for one point each, adding a photo is worth three points with a total of five photos per person per arena and the story submission is worth 10 points with one approved submission per arena.

The judging will take place on March 3 and the Top Four finalists will be announced on March 15.

Arena fans can start voting on April 4 at 9 a.m. ET (7 a.m. Mountain) until 5 p.m. ET (3 p.m. Mountain) on April 5, which is the same day the winner will be announced.

The arena that receives the most votes will be deemed the winner.

Arenas finishing second, third and fourth will receive \$25,000.

City to amend CAO bylaw

City council committee tabled their discussion to amend the CAO's bylaw due to the absence of CAO Chris Parker.

Some of the changes in the city's bylaw are in part because they are part of the Municipal Government Act (MGA).

The bylaw includes updating the definition of CAO, removing duties and/or powers of the position already part of the MGA and updating references to

the budget process with the current practice.

Instead of being directed by council to review and enter into agreements up to \$50,000, it is proposed that the CAO will be able to enter into agreements and contracts that do not require council approval, such as retaining services relating to the operations of the city.

The CAO would be able to authorize cumulative over-expenditures within the operating or capital budgets and report those changes to council during the quarterly

variance report.

The CAO would not require any elected official to be part of the hiring process when interviewing at the director's level and the CAO would determine salary, etc within the budget after it has been adopted by council.

The organizational chart will no longer be authorized by the council but when changes are made it is to be presented to council for information only.

Council committee is expected to discuss the bylaw at the next meeting.

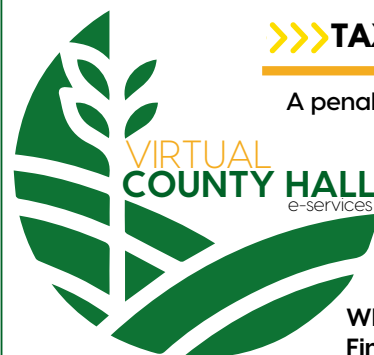

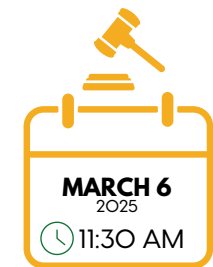

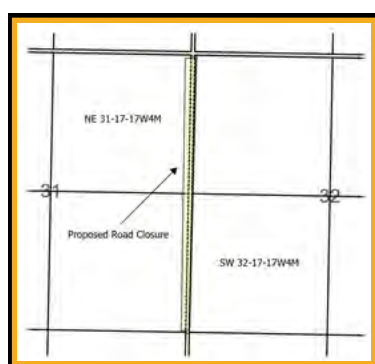

County wants to reduce insurance burden on community organizations

County council is investigating a way to help community groups deal with increasing insurance rates.

Community organizations are experiencing significant increases in insurance, Layne Johnson, the county's director of corporate services, told council recently.

He said options were considered to make it less costly for groups such as suggesting that they consider increasing their deductible to reduce their premium.

"We're talking about encouraging them (ie ag societies) to increase their deductible and if they do that, the funding that kicks in from the county would offset their cost in the event of a claim," he said.

CAO Matt Fenske said an impact was seen on the county's insurance rate when the Duchess soccer centre burned down November 2012.

Fenske suggested that while the county is in a relatively strong financial position, it could be an opportunity for some funds to be used to cover a deductible program.

"That leverages the county's financial strength, it takes the requirement

off the community groups to sock away funds for an increased deductible and long term, I'm hoping the county actually benefits by a reduced funding need," he said.

"I think this is a potential win-win for the county and the community groups that council supports."

Johnson said the replacement cost value is driving the overall increase and premium.

"Inflation has had a significant impact on the cost of construction and that's what's impacting your

property insurance," he said.

"If any of these options has the potential of lowering our insurance rates, I'd be willing to look into it," said councillor Dan Short.

Darcy Hemsing, president of the Rolling Hills Ag Society hopes the county will be able to assist.

He said they receive about \$250,000 from the county of which about \$50,000 has to be used to insure recreation facilities in the hamlet.

Johnson will return to the council with a program for council to consider.

Lake Stafford path may see lights installed

Mayor John Petrie ran on a promise to get lights at Lake Stafford and it just may happen this term.

On Monday city council committee agreed to apply for federal funds through

the Active Transportation Fund in hopes of receiving 60 per cent of the costs which are estimated at about \$250,000.

The program would involve 80 LED lights installed around the trail which is believed would increase usage all year while

acting as a way to deter vandalism and increase security.

The city's linear trail program has \$100,000 set aside for 2025.

City council was to further discuss the initiative during Monday's council meeting.



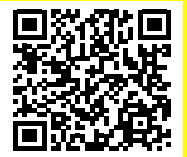

When it comes to federal advertising, the government should 'buy Canadian'

Why are millions of dollars going to foreign tech giants while Canadian media suffers?

As a proud second-generation Canadian community newspaper publisher, who is the lead plaintiff on a class-action lawsuit to make sure U.S.-based tech giants don't rip off publishers like me, I was gobsmacked to see that the Government of Canada is using my hard-earned taxpayer dollars to resume advertising with Meta Platforms.

Anyone who watched the inauguration of U.S. President Donald Trump will know that Meta CEO Mark Zuckerberg seems more interested in checking out Lauren Sanchez than he does about fact-checking the content on his platforms, which spew misinformation and disinformation faster and more broadly than anything in human history. In fact, he fired his fact-checkers, seemingly to curry favour with President Trump.

Here are the facts my fellow Canadians should know about federal ad spending. Last year, according to the government's annual report on its advertising activities, the feds spent more than \$75 million on advertising. I don't have an issue with spending this kind of money to inform Canadians about what their government is doing. But I have a problem with how the government is trying to reach Canadians.

Of that \$75 million or so, the feds spent nearly \$40 million on digital ads, including over \$8.5 million on search engine marketing and more than \$6.5 million on social media. In comparison, radio got just \$2.5 million and print publications received less than \$1.4 million. That's about two per cent of all federal ad spending on every English, French and ethnic newspaper and magazine throughout the entire country. Yet 86 per cent of Canadians read a newspaper weekly. Newspapers, and ads in newspapers, are trusted.

Here's a case in point: Recently, Totum Research conducted an online survey on behalf of News Media Canada, which found that almost two-thirds (63 per cent) of Canadians trust advertising in newspapers and news websites, while just 28 per cent trust ads they see on Facebook and Instagram. When it comes to their preferred medium to receive information about federal programs, more than half (58 per cent) of respondents cited newspapers or news websites, while only 17 per cent chose Facebook or Instagram.

The feds need to instruct their agencies to get their advertising acts together. For inspiration, they should look to Ontario Premier Doug Ford, who came up with a simple, common-sense solution that doesn't cost Ontario taxpayers one extra cent. His government and its Crown corporations — like the LCBO, OLG, the Ontario Cannabis Store and Metrolinx — are now spending 25 per cent of their ad budgets on local publications. This supports a local Canadian industry that is losing ad dollars to American tech giants.

Local community newspaper publishers like me want the federal government to adopt Ford's common-sense approach. Conservative Leader Pierre Poilievre, NDP Leader Jagmeet Singh, along with Liberal leadership hopefuls Mark Carney, Karina Gould and Chrystia Freeland should pledge to resume the federal ban on advertising with Meta. If their campaigns want to use Meta, that's their business, but no Canadian taxpayer dollars should be flowing to the company.

Donald Trump's tariff threats and his rants about annexing Canada are probably the biggest contributors to Canadian pride since the Montreal Canadiens won the Stanley Cup way back in 1993. Like most patriotic folks I know, when I'm at the grocery store, I'm now double-checking labels to make sure my beef is from Alberta and my apples are from British Columbia. And I'm buying Ontario and B.C. wine, too.

Likewise, our federal government has to get in sync with Canadians when it comes to its advertising spend. Come on, Canada: let's support the home team — and would an all-Canadian Stanley Cup final between Toronto and Edmonton or Winnipeg be too much to ask for?

War: Two Steps Forward, Two Steps Back?

In classical civilisations, there was a continuing, unresolved debate about whether history moved forward or just went around in circles: was it linear or was it cyclical? But that debate was largely settled once human beings learned about their deeper past. It's linear.

Once every human being was a hunter-gatherer; now almost none of us are. Once nobody lived in groups more than a couple of hundred strong because bigger groups just fissioned; now most of us live in societies many millions strong. You don't have to call it 'progress', but history certainly has a direction. Which is not to say that it's purely linear.

Just as rivers always flow downstream but may contain many eddies and whirlpools, history can double back on itself. The history of war has already done that several times. There is reason to suspect that it may now be doing it again.

Before the rise of big civilisations, battles between the little human groups of pre-history were frequent, relatively low-intensity, but cumulatively very deadly. Everybody lived on the front line all the time, and early anthropologists estimated that 30% of males (and 5% of females) were killed in war in every generation.

The advent of mass societies brought much bigger battles, but they were less frequent and involved a much smaller proportion of the society. (The

Roman army at its peak was just under half a million men; the Roman population at that time was around 50 million.)

A lot of people got killed whenever pastoral peoples like the Mongols broke into the civilisations, but medieval warfare in Europe and its parallels in China and India stayed relatively small until the 1600s. Then Europe went crazy.

The Thirty Years War (1618-1648) began mainly as a religious civil war in the German-speaking lands, but it ended up as the 'war of all against all' and an estimated 8 million people died. That was about 12% of Europe's population at that time, and it frightened the survivors into making new rules.

Starting in the mid-1600s, existing countries became 'sovereign', and in the next century and a half no major European state was carved up except Poland. Armies became small and professional, and war in Europe shrank back down to a marginal activity that scarcely impinged on the civilian sphere.

But then came the French revolution in 1789 and the Napoleonic wars that followed, with mass armies of volunteers, ideological conflict, and whole states being dismantled. Fast forward to the First World War, 11 million dead, and all the regimes on the losing side (plus several on the winning side) driven from power.

Then the Second World War, 45 million dead, and nuclear weapons by the end. Once again, all the regimes on the losing side destroyed. Time for another go at taming the beast — and amazingly, this time it really seemed to work.

It has been 79 years since the last nuclear weapon was used in anger, and the death toll in wars has fallen from a million a month

in 1945 to under 100,000 a year in the early 2020s. But now it's going back up again — just a bit, maybe half a million in 2024 — but the trend line is worrisome.

Much more worrisome is the fact that just in the past few years all the institutional and legal barriers we put in place to prevent or limit the spread of war have been sabotaged or abandoned. The keystone of the system, the United Nations, was crippled long ago by rival vetoes, but now the foundations are being dug up and cast aside.

The bedrock on which the entire post-1945 system was built is the inviolability of borders. No changes to borders after that date will be accepted by the rest of the world if they were changed by force. Indeed, even attempts to change a border by force, whatever the justification, are illegal. Only voluntary, negotiated, uncoerced changes are acceptable.

That rule has enjoyed almost universal support in principle because all the players understood that this is the only way to end the endless cycle of wars. Nobody is actually obliged to go and fight some other country to stop it from breaking that rule, but their conquests will never be accepted by the rest of the world. So they might as well not do it.

That is the rule which is now being ignored by the greatest power in the system. Russia can claim that the 'old border' of the Soviet Union included Ukraine, and China can at least claim an ethnic link with Taiwan, but Donald Trump demanding to take over Greenland, the Panama Canal, Canada and the Gaza Strip is empire-building of the crudest sort.

If he gets away with that, it's back to the old ways again.

Fast time line for Bow River nomination

With a federal election looming, the nomination date to find a Conservative candidate for the Bow River Riding is coming even faster.

All nominations are to be submitted by Feb. 25 at 5 p.m. Eastern Time.

Anyone who was a member of the Conservative Party as of Feb. 13 are eligible to vote, however, a date has not been announced.

The race to replace MP Martin Shields started before he publicly announced his intention not to seek re-election.

As of Saturday Graham Abela, David Bexte, JL DeCosta, Ritesh Narayan and Josh Senneker have confirmed they will seek the nomination.

There has been some predictions that the federal election will be called as early as March 10, one day after the election of a Liberal Party leader.

According to a letter obtained by the Globe and Mail from Jennifer Howard, the NDP federal campaign manager, "If Mark Carney does win the leadership, we are hearing from many Ottawa sources that he intends on calling an election shortly after becoming Liberal leader."

Carney was considered as a prime minister Justin Trudeau replacement in 2019.

Carney's main opponent in the Liberal leadership race is Crystia Freeland who has been elected four times.

On Dec. 16, the day she was to deliver the fall economic update, Freeland resigned from Trudeau's cabinet.

That move was a catalyst to Trudeau's resignation on Jan. 7.

Ten days later she launched her campaign to lead the Liberal Party of Canada.

Meat promoters have some disadvantages - part two ... pacifying producers a factor

Previously, I commented on the success of milk production Television (TV) ads with their focus on happy, photogenic cows and happy, handsome farmers on spick-and-span farms. For meat promotion, it's another story. That's not to say there aren't happy hogs and cattle and happy, handsome cattle and hog producers on pristine hog farms and picturesque cattle ranches. However, both groups' ad agencies have to deal with a less-than-happy reality that naïve consumers would rather not deal with in their simpleminded perspective of how meat arrives at their grocery store. The biggest advantage dairy promotion has over meat promotion

is that, like their egg-producer compatriots, their commodities do not require the slaughter of animals to produce their food product. The best approach has been to never even allude to that unpleasant reality – and rightly so.

In a previous life, I was involved in the only lamb TV commercial ever broadcast in Canada. It was a sophisticated generic “eat lamb” commercial produced by the promotion arm of the American Sheep Industry Association, who kindly loaned it to the Alberta Sheep Commission of the day. I cheekily added the words “Buy Alberta Lamb” at the end. I expect it was a Canadian first to this day. That's when I learned how expensive TV advertising was, even for the cheaper off hours when the commercial ran. The US group had a budget of tens of millions and produced several slick lamb commercials and glossy point-of-sale material. But they

never showed images of a pretty shepherd with cute live lambs romping around a pasture. It's better to keep negative thoughts about the fate of those cute lambs from the minds of naïve consumers.

Cattle producer groups have different approaches – promote the final product from a local angle, that being “Alberta Beef” (the greatest national meat brand ever), “Ontario Corn-Fed Beef” (boring) or “Boeuf Quebec. A Taste of Home” (do they raise real beef?) Okay, I am biased. I am not sure those brands really increase beef consumption, particularly the Alberta Beef brand, which preaches to the choir here in Alberta. It's an old sawhorse of mine, but using the legendary Alberta Beef brand in big eastern urban markets would be much more effective. In my long-ago youth living in Quebec, “Alberta Beef” was an

iconic premium brand that was the high-quality standard of the country. But I know provincial producer group politics discourage using that brand in other provinces. But really, does anyone care about Ontario or Quebec beef, even in those provinces. Forgive my rant – but it's true.

The old Beef Information Centre and later Cannada Beef Inc. were supposed to resolve provincial beef brand chauvinism with a national brand. However, the provincial brands still carry on. Luckily, Canada Beef spends most of its budget on US and offshore export marketing. They have to be strategic in advertising; I suspect they have much less funding than the well-heeled dairy industry. Another advantage the dairy promotion juggernaut has is that it doesn't spend ad money on export markets and focuses its moneyed efforts on the Canadian market.

Recent TV commercials from the Alberta Beef Producers brought to mind their past commercials and that organization's challenge in producing TV ads. The challenge is that they want to promote positive consumer perspectives about beef and also show their members that they are getting value for their hard-earned check-off money. I recall some of the first beef ads 40+ years ago, which featured a distinguished-looking rancher on a horse overlooking a hill of grazing cattle, extolling how wonderful it was to raise cattle – it looked more like a tourist travel promotion. The beef marketing brain trust then started commercials with the jingle “Jack Sprat Had No Fat – neither does beef” or something to that effect. Producers were annoyed with that campaign; they preferred the rancher on a horse because they could relate to that

image. Changing that producer perspective took years. I believe that, to this day, Alberta Beef commercials keep producer backlash in mind by featuring images of ranchers in their Alberta-focused promotion efforts. Recent commercials featuring ranching families enjoying Alberta beef meals – is a much better approach. Showing them in Vancouver and Montreal would be even better! Other Alberta beef commercials about sustainability and stewardship are okay and environmentally correct. But I think jaded city consumers have become deaf to overused enviro buzzwords, like sustainability, net-zero, emission-free; they all become so tedious.

How Canada gets its groove back: Advice from a friendly American

Political theorist David Polansky says Justin Trudeau has it wrong: Canada does have a core identity.

“Canada really is a fundamentally rich country that has chosen not to act like one for 10 years,” says political theorist David Polansky.

If you ask the average Canadian — “Are you ashamed that you're an oil and gas giant and have all these incredible minerals?” — the answer is no. But it's a sentiment that's dominant among the governing class, David asserts, and “that governing class is not very representative.”

David, an American now living in Toronto, writes on geopolitics, international orders, nationalism and state-formation and is senior fellow at the Institute of Peace and Diplomacy. He studied at the University of Chicago and the University of Toronto to investigate the future of nation-states in an increasingly uncertain world. Turns out, figuring out the good and the bad of nationalism, patriotism and populism — in an era of Brexit, Russian ambition and Trump 2.0 — wasn't an academic exercise.

“Canada is the third foreign country I've lived in,” David shares in a recent conversation; he's also lived in China and Italy. That's a fair amount of bouncing around for a 43-year-old, I think

to myself, but he seems settled. His wife hails from Montreal and together they've decided Toronto is a good place to call home and raise their kids.

David's been paying close attention to Prime Minister Justin Trudeau's experiment with Canadian identity. Both of us wince recalling Trudeau's infamous 2015 statement to the New York Times: “there is no core identity, no mainstream in Canada” and consequently that “makes us the first post-national state.” A few years later, when I questioned Trudeau's heroic defence of a post-nation world (and consequential neglect of his own country) in a commentary for the CBC, the CBC itself and CBC, the CBC itself and a whack of like-minded progressives cancelled me.

The real test of the idea of a post-national state, David explains, is what do you do when the chips are down: “Can the ethos of a post-nationalist state stand up and establish legitimacy when times are tough? That's how you know you have a good marriage; when you could weather a bad year.”

Trudeau pushed this radical new version of nationhood, David opines, and convinced people not to attend to what really matters: “the important parts of upholding a

nation-state.” And now, when the chips are down, we see the insubstantiality of the idea. David judges Trudeau's experiment with post-national governance an epic failure.

Nationalism is what governments fall back on when things are bad. And this is what Trudeau's now saying — “oh, we do have a country, it is Canada.” All together now, wave that Team Canada flag! But having gutted and removed some of its essence over the years, we're now in a bit of a pickle, David reports, with a nervous rake of fingers through his thick hair.

There's lots to be proud of as Canadians: “It's a gorgeous country. It's a stable country. It's a peaceful country. It's a place that's provided a good life to many millions over the years.” All political communities are going to have dark sides and stains on their consciousness, David acknowledges, there's no avoiding that. But all things considered, Canada still comes out looking pretty good in the grand scheme of things.

Wholeheartedly, we are in agreement; there's plenty of basis for patriotism in Canada. Yet, David asserts, we've had leaders and dominant institutions hostile to the

nation, pushing a sort of false moralism — a rainbow coalition and so on — as a new way of thinking. So many institutions have allowed mediocrities to rule them, who have propounded a very hostile ideology to the idea of a Canadian nation, David laments.

Take the CBC, for example; if you were an alien from another planet, you would find CBC not critical of the government (which is what, of course, the media should be) and instead, it's critical of the Canadian people. “Speaking as an American,” David counters, “it's very hard for me to look at Canada and think, yes, you have so much to hate yourselves for. The adoption of those habits, those mental habits, has been very bad.”

Canadian citizens need to push back, not just against politicians but ordinary bureaucrats. “Look at the school board trustees, mayors,” David says, “I'm struck by how much the default discourse is hostile to the possibility of Canadian patriotic projects.”

Over time, he suggests, that seeps into the culture and people just throw up their hands and are less inclined to be engaged. “And when you do have a real threat, like the

Trump tariffs may prove to be, what's left besides expediency?” he asks.

Ordinary people, David suggests, need to challenge the governing class: “Why are you here? Why is this your job? Why are you lecturing us? What is the moral basis for you to come up here and talk and run down the entire country without remotely trying to put anything positive in its place?”

We can't have this conversation without contemplating the chaotic portents of Donald Trump's inauguration as America's 47th president. Across Canada, Trump's threatened tariffs trigger rage, an insurmountable gloom, even fear of Manifest Destiny's revival. David's an American; what does he see?

Trump's a “creature of pure expediency,” David replies, “he has never given me any indication of someone who has a strong set of political ideas independent of his own whims and interests.” His assessment: Don't think of Trump as someone with a set of clear political ideologies that he's trying to execute in office.

But, David agrees, Trump is a very good negotiator. And “it's a good negotiating tactic to get the person you're going to be negotiating with all in

a tizzy for months before you actually have to do anything,” he smirks. “It puts him at a disadvantage and then it allows (Trump) to seem magnanimous. Anything he doesn't do to Canada now will make him seem magnanimous.”

David gets the anger; he's even written about how Canadians need to be more angry. But there are limits to anger, he suggests, pointing to Brexit: “They had good reasons to be angry and good reasons to feel alienated from the governance of the EU, and yet, almost none of the things that they were actually upset about changed after Brexit. All the same problems were still there, except now they had new ones, thanks to Brexit.”

And what of all this talk of retaliation? “Retaliation is fine,” David nods, “but it has to work. You have to have real leverage.” If I go up to a 300-pound guy and smack him in the face because he insulted me, David explains, that's not retaliation, “that's just an invitation to have my face driven into the ground.”

Canada has resources, David agrees, “And so it's not that I don't think leverage doesn't exist, but you can't just, you know, go and find it after pretending it wasn't there for years.”

JBS road work could be underway in May

The county, which is administering the engineering and construction contracts for the JBS Foods Canada road, anticipates construction this year.

CAO Matt Fenske confirmed that engineers are working on the pre-tender engineering work including topographic surveys, identifying utility conflicts, preliminary drawings, cost estimates, and evaluating off-site impacts of shifting traffic patterns.

Once that work is finished, there will be detailed design work and contract documentation to be completed and ready to go in mid-May.

"The goal is to see construction in 2025," Fenske said.

Improvements to the area will include a new road from the south parking lot of the meat plant to Gun Club Road as well as improvements on Gun Club Road (Township 19-2).

The purpose of the improvements is to help ensure that motorists from the plant can not only avoid 90-minute bottleneck during the shift change but to also use Gun Club to avoid an often dangerous left turn from the plant across Highway 1.
